# FOREWORD



The year 2019-20 was significant for Railway Children India's fundraising function. After more than one and a half years of our effort to stabilise our fundraising function, we saw positive outcomes this year. We acquired one new corporate donor, 1663 individual donors and we became active on social media kicking off our digital fundraising efforts. This was one of our pivotal strategies this year, with the ambition to build a key pillar of sustainability i.e. an efficient fundraising machine. This year was also the mid-year of our 5 years ongoing strategic plan. We spent significant time reviewing our learnings from previous years and revised the plan for the rest of the strategic plan period. Now with the new realities created by COVID 19, we will be revisiting the plan again by recreating scenarios based on informed assumptions that will guide us in future.

COVID 19 and the lockdown has dramatically impacted all our lives in one way or another. It has affected RCI too, at multiple levels. All our railway station work suspended immediately after the lockdown was announced. Three of our projects lost funding as the corporates had to hold on to their decision to renew the partnership with RCI beyond 31st March 2020. At the same time, we witnessed a massive surge in the need to protect children in difficult circumstances with no additional funding available to respond to children in a time of crisis. To be honest we were all overwhelmed initially. But, almost immediately, we pulled ourselves together, formed a task force and decided to face the crisis head on. We focussed on what was within the ambit of our control. Reached out to current and potential donors (individuals, corporate and institutional), connected with families with whom we reunified children in the past and engaged with our key stakeholder i.e. The Indian Railways. As a result, we are now supporting 900 + families and children in distress through dry groceries, providing psychosocial support to more than 3000 families and children and supported 16,000 migrant labours boarding Shramik express with food and water.

I take this opportunity to thank Azim Premji Philanthropic Initiatives, Dasra, PVR Nest, Honda two wheelers and Apax foundations for helping us through this difficult time. I thank all the individual donors who reposed their trust on us at such a difficult time. We received unconditional support from our board of Directors, which was a great source of motivation. It was inspiring to witness the commitment and courage shown by every single team member of RCI who are working very hard to help the organisation recover from the current crisis, and at the same time stay focused on our vision to create a world where no child every has to live on the streets.

# MATCHING GOALS TO ACTIONS




## 1. PROTECTING CHILDREN & CREATING CHILD-FRIENDLY RAILWAY STATIONS

Our child-friendly station model has been incubated with the view to prevent and respond to the multi-faceted violations, abuse and exploitations children can potentially face when they arrive at Railway Stations. Our work attempts to broaden and strengthen the knowledge, skills and attitudes of protection officers and field staff, connect missing, lost, abandoned and runaway children back with their families or with temporary or long-term care, based on the needs of the child.



## 1.2 FIRST OPEN SHELTER IN KATPADI, VELLORE

In collaboration with our partner organization in Katpadi, we were successful in procuring permission from the Department of Social Defence, Government of Tamil Nadu, with the objective of setting up an Open Shelter in the district. Inaugurated by the District Collector in the last week of February 2020, in the presence of district and state officials of the Juvenile Justice system, he made a special mention of Railway Children India, Light Foundation and our partner organization and appreciated our work in protecting children. Declared as the first open shelter home for children in the district, it was also recognised as a child-friendly space for children.

## 1.3 THE START OF THE ASPIRATION TREE AT TRICHY SHELTER HOME

In an attempt to remodel our open shelter home in Trichy, and make it more child-friendly, we began brainstorming on ideas. We narrowed down on creating a visible method through which we could depict how our interventions were bringing colour to the lives of many children. With the primary aim to encourage children in vulnerable situations to dream and aspire, we incubated the 'Aspiration Tree'. This tree was symbolic in nature, that encouraged all children who entered the open shelter home to interpret it in their own unique way and make their mark through their handprint. Together, the handprints of all the children, added colours and aspirations to their lives.

## 1.4 A 24X7 CHILD HELP DESK AT DADAR, RAIPUR & GHAZIABAD STATION

In collaboration with PVR Nest, a 24X7 Child Help Desk (CHD) was set up at Dadar, Raipur & Ghaziabad Railway Station. Colourfully painted to make it child-friendly, this CHD was equipped with a first aid kit, clothes, dry food, water, and playing material, to cater to the immediate needs of children accessing it.


## 1.5 DEVELOPING READING HABITS AMONGST CHILDREN AT OPEN SHELTER HOMES

At the Open Shelter home in Ghaziabad, a library for the children was launched on 13th September, 2019 to provide educational, recreational, and cultural resources for them. It has a large collection of picture books, story books, nonfictional books etc. The objective of setting up a diverse library was to help develop reading, research, and creativity skills amongst children.

## 2. CATALYZING CHILD PROTECTION AMBASSADORS

A critical area of our work includes catalyzing civil society, government stakeholders, parents, families and other key stakeholders to become ambassadors for child protection in their circles of influence, working towards building a concerned community for child protection. It is only by creating awareness, sharing knowledge and empowering individuals to take informed action towards child rights and protection that children will be safe.

### 2.2 STUDENT'S COME TOGETHER TO CREATE AWARENESS AT DARBHANGA RAILWAY STATION

End September began with the distribution of leaflets amongst 2000 people at Darbhanga Railway Station. During this initiative, students from Gyan Bharti Public School, the NCC team from MLSM, College and station level stakeholders played a critical role by directly participating and creating a buzz around our work at Railway Children India and issues of child rights and protection. Similar events were conducted at all our project locations too.

### 2.3 OPERATION PAREE III - RESCUING MISSING CHILDREN IN COLLABORATION WITH GOVT. OF ODISHA

The District Child Protection Unit in Khordha invited our station level team to extend their support to Operation Paree-III, a campaign launched by the Government of Odisha to rescue missing children from various parts of the state. This 13-day campaign from end July to mid-August, helped 39 children being rescued.

2.4 BETI BACHAO, BETI PADHAO, A CAMPAIGN FOR GIRLS

In collaboration with Humara Bachpan Trust (HBT) we organized a week-long campaign in February 2020. The theme of the campaign was Beti Bachao, Beti Padhao (Save the daughter, educate the daughter) with the aim to generate awareness and improve the efficiency of welfare services intended for girls in India. We were able to reach out to 2249 passengers and other stakeholders at the railway station that resulted in stakeholders referring 32 children to the Child Help Desk (CHD).



2.5 PARTNERING WITH DELHI COMMISSION FOR PROTECTION OF CHILD RIGHTS (DCPCR) TO SENSITIZE COOLIES & VENDORS

On 4th February 2020, Railway Children India organised a workshop with the cleaning staff, coolies and vendors of Delhi Sarai Rohilla Railway Station, in collaboration with Delhi Commission For Protection of Child Rights (DCPCR). The workshop was aimed at educating secondary stakeholders on “How to identify children alone, missing and vulnerable children at and around the Railway Station and how to help them”. Almost 19 coolies & vendors participated in the workshop and learnt about child protection issues. This workshop was rolled out in the presence of the station superintendent. This also demonstrated the increased sensitivity of the officers in protecting the children. Mr. Ravi Shanker (Project Manager, Railway Children India) oriented all the participants on the given subject in the presence of Mrs. Samrah (Member, DCPCR) and Mr. Arun Sharma (Consultant, DCPCR).



# 3. WIDENING THE CIRCLE OF CHILD PROTECTION

Our continued work in collaboration with the Indian Railways, has been a step towards widening our reach and sharing knowledge on child rights and protection, with those who come directly in contact with children. Mobilizing key actors has only assisted in strengthening the child protection ecosystem and making it more robust for children.

**3.1 10721 RAILWAY OFFICIALS WERE TRAINED ON CHILD RIGHTS, PROTECTION AND RELATED LAWS IN CONTEXT TO THE RAILWAY'S SOP, GUIDEBOOK & 124 TRAININGS WERE CONDUCTED AT RAILWAY TRAINING INSTITUTES (RPF ZONAL TRAINING CENTRES, RPF ACADEMY & ZONAL RAILWAY TRAINING INSTITUTES), RAILWAY DIVISION, RAILWAY STATIONS AND DISTRICT LEVEL.**

## 3.2 DISTRICT LEVEL PLATFORM FOR SHARING OF LEARNINGS & CHALLENGES, GHAZIABAD

In collaboration with the District Child Protection Unit (DCPU) of Ghaziabad, we organised a district level stakeholder meeting on 4th May, 2019. The officials of DCPU, members of the Child Welfare Committee (CWC), chief functionaries of NGOs, the home superintendent of the Child Care Institutions (CCI) run by Govt. and Non-Government Organisations in Ghaziabad, participated in this meeting. This gathering contributed towards developing a platform at the district level which would allow CCI's to come together on a regular basis, to share their learnings and challenges, and collectively work towards providing better care to children. This translated into the DPO seeking a list of restored children from Railway Children India in order to link them to the Government sponsorship scheme.



## 3.3 STRENGTHENING CHILD PROTECTION MECHANISMS AT RAILWAY STATIONS, DARBHANGA

3 Child Help Group (CHG) meetings at the Darbhanga railway station were organised to strengthen child protection mechanisms at the station. At the meeting, the Station Superintendent accepted the suggestion of the project team to encourage ticket counter staff to alert the outreach team if they suspect any passenger buying ticket for multiple children, strengthening night outreach with the support of railway staff and providing shelter support for children (3-4 hours) reached out during night time.

**3.4 FELICITATING OUTSTANDING CONTRIBUTIONS TOWARDS CHILD PROTECTION - ABHINANDAN**

Abhinandan programmes were organized by Railway Children India in collaboration with the Indian Railways to felicitate the railway officials for their outstanding contributions towards child protection at Railway Stations. In 2019-20 3 Abhinandan events were organized- Southern Railways in November 2019, Northern Railways in Jan 2020 and South East Central Railways in February 2020. 109 Railway Officials (RPF, Commercial & Operating) were all felicitated during these events.



**3.5 EXCLUSIVE TRAINING FOR INDIAN RAILWAY TICKET CHECKING STAFF ORGANIZATION (IRTCISO) STAFF MEMBERS**

The IRTCISO is the only organising/union which represents ticket checking staff of all Indian Railways. The engagement with IRTCISO has enabled Railway Children India to address TTEs/TCs on a large scale on the issue of child protection from time to time. Approximately 950 Ticket Checking Staff i.e. TTEs and TTs have been addressed by RCI on child protection issues in 2 mega events organised by IRTCISO at Bikaner Rajasthan and Hubli, Karnataka. IRTCISO additionally updates about children who have been protected by TTEs/TCs on their official facebook page too. The engagement with IRTCISO has enabled us to address TTEs/TCs on a large scale on the issue of child protection. This type of engagement with Railway Organizations and their officials has helped RCI in building a long-term relationship and agenda with the Railways as a resource organization on child protection. The result has been that 129 children were protected by 98 staff members between June 2019 – March 2020.



# 4. INVESTING IN CHILD PROTECTION

Our fundraising goals are closely linked with our vision to collectively invest in protecting children. It is by investing in preventive work, developing effective models, equipping stakeholders and communities and strengthening existing child protection systems that we can build a well-oiled ecosystem for protecting children. Our efforts to raise funds were met through digital, individual and corporate fundraising over the year.

It was our first year exploring digital fundraising, in an attempt to increase our donor base and build an online community, done through multiple fundraising and lead generation campaigns.

## 4.3 DONOR SUPPORT



Our commitment to protect children is clearly articulated and actioned with this policy as our foundation.


**AFTER HIS FATHER'S SUICIDE, HUMILIATION FROM RELATIVES & DROPPING OUT OF SCHOOL...DEEPANSHU FINDS HAPPINESS AT HOME AGAIN.**

Deepanshu (name changed) was just 8 years old when his father committed suicide due to the burden of an increased debt. Ever since, Deepanshu, now 10 years old, has been staying with his mother in his maternal grandparent's house in Muradanagar, Uttar Pradesh. At his grandparents' house he was always humiliated, taunted and punished by his close relatives.

Deepanshu's mother worked at a salt factory near Murada Nagar in Ghaziabad district and his sister who was 16 years old, was forced into an early marriage by her relatives. His brother who was 14 years old was addicted to substances, making life tough. Amidst all these troubles, Deepanshu was unable to focus on in school and quit school, in the 3rd Grade in order to support his family in household work. One year later, he couldn't take it anymore and decided to leave home. He boarded a train from Muradanagar and arrived at Ghaziabad Railway station on 29th January 2020, to be found in a distressed condition by our outreach worker, on platform no.3. After taking him to the Child Assistance Booth (CAB) and following protocol, the Child Welfare Committee referred the child to the RCI Open Shelter for short stay.

In the initial few weeks Deepanshu was not sharing any information or mingling with the children. However, the team was able to engage him to undertake daily activities and started spending more time with him. Gradually, he was able to build trust with the counsellor and shared his story. He was provided counseling regularly. During one of the counselling sessions, Deepanshu shared about his father committing suicide and all the humiliation and abuse he had gone through by his relatives that led him to quit school. He emphasized that he did not want to get back home.

After 4 weeks Deepanshu expressed his desire to meet and talk with his mother and sister. The Child Welfare Office visited Deepanshu's family to assess the family situation. Deepanshu's family was also provided regular counselling during the visits to the Open Shelter home. After several rounds of counselling's and discussion with parents, Deepanshu finally went back home. Today, Deepanshu is happy to be back home, enrolled in a formal school, while our team works with his brother to convince him to go to a de-addiction centre.



# FROM RUNNING AWAY FROM HOME TO DREAMING OF BECOMING AN ENGINEER

Satish was 14 years old when our outreach workers found him wandering around the station at Trichy. Initially, he was reluctant to talk or share any details about himself, so we took him to our nearby shelter where he was given something to eat and drink. As he felt more relaxed, he explained his story, what had happened to him and why he was alone at the Railway station. Satish’s father was abusive and violent. His problem with substance abuse made him lash out at the family often. One fateful day, in a fit of anger, he tried to strangle Satish’s mother and the neighbours reported this incident to the police.

Satish’ father was sent to prison, and while there, he committed suicide, shattering their entire family. Neither his mother or younger brother were able to cope with this trauma, and Satish too got into trouble at school after some boys started teasing him about his father killing himself. Unable to take it anymore, Satish ran away from home and found himself at the railway station, at an extreme risk of trafficking, violence and abuse.

After working with Satish and his family for several months, we helped him realise that he would be best going back to school. Unfortunately, he had missed so much time away from school, that he couldn’t get in. Our team worked intensively with him in all subject areas until he passed his class 9 exams and was able to reenroll at a school near his home. Satish, his mother and his brother all needed our ongoing support to make sure neither child was at risk of running away again. The relationships between them have been severely impacted by the trauma they have all been through, and our role therefore was to help them strengthen those bonds and rebuild their lives together. Our counsellors helped them process those experiences and focus on loving and caring for each other. Today, Satish’s mother works hard by cooking and cleaning for three households so she can support her children, and Satish is diligent and conscientious at school where he loves PE and has started to make friends. He loves to fly his kite and dreams of passing his technical diploma so he can be an engineer.



# RUNNING AWAY FROM HOME WITHOUT UNDERSTANDING THE IMPLICATIONS OF EARLY MARRIAGE, RCI TEAM COUNSELS TEENAGERS TO TAKE THE RIGHT STEP

At noon, one December morning, our team members found a young boy and girl standing at Platform no.1 of Raipur Railway Station, whispering to each other and looking rather fearful. The team decided to approach them, but their initial reaction was of scepticism. With a little coaxing, the children shared their identities and were taken to the Child Help Desk (CHD).

Phool Kumari (name changed) a 16-years-old girl studying in class 9 & Saumya (name changed), a 17-year-old boy studying in class 11 were both from Udaipur Village, Rajnandgaon district of Chhattisgarh. Studying at the same school, both the boy and girl were in love with each other for a long time. Recently, the girl’s parents had found out about their relationship, and she was afraid that would stop her from going to school altogether...so she left home and went to her boyfriend’s house, carrying nothing but a few clothes in a bag. Hearing Phool’s worries, Saumya felt compelled to runaway with her as Phool was insistent that she would not go back home. The two, took a bus to Rajnandgaon, 35 kms away from their village, without a plan in place. After spending the night at the Railway Station, they took a train the next morning to Raipur.

The team members heard them out and counselled them about the legal implications of marrying below 18 years of age, and the problems that would arise thereafter. The parents were informed, and 2 days later they came to the CWC Mana Camp. With repeated telephonic follow ups, the boy now goes to school, and the girl is under the care of her grandmother.


**WE WORK AND INTERVENE AT THREE LEVELS FOR LASTING AND LONG TERM CHANGE:**

**AT AND AROUND THE RAILWAY STATION:** RCI aims to transform stations into child friendly spaces. A team of outreach workers (ORW) work round the clock to reach every child arriving or passing by the station alone. The ORWs are entrusted to ensure the first response to the child's need, i.e. food, water, medical and counselling support etc. The first response centre is located at the station as a Child Help Desk, to cater to the needs of every child identified.

**IN COMMUNITIES:** Railway Children India (RCI) works to create a safety net within the community, so that none of the children fall through it, and become vulnerable. RCI believes in empowering communities and families and strengthening their resources so they have the responsibility and ability to properly care for their children and keep them safe.

**WITH GOVERNMENTS:** Strengthening the existing government system and structures is key to ensuring long-term, sustainable change which is what we work towards, and what allows us to have the greatest impact, where needed most.
